**Migration of MP IGR e-stamping portal from Sampada 1.0 to Sampada 2.0**

The Inspector General of Registration and Superintendent of Stamps (Commercial Taxes Department), Government of Madhya Pradesh has switched from the current Sampada 1.0 to the new portal i.e. Sampada 2.0. w.e.f. 01.04.25. However, at NeSL's request, and to facilitate transition to the new portal, the IGR permitted NeSL transactions to be continued in Sampada 1.0 portal. We have now been advised that Sampada 1.0 will be fully decommissioned with effect from 30.06.2025.

**NeSL will go live with Sampada 2.0 w.e.f. 01.07.2025.** All the banks, NBFCs and other users of NeSL's DDE are requested to transfer fresh funds for Sampada 2.0. The issue relating to outstanding balances in Sampada 1.0 are under discussion with the state government and the banks concerned.
