SHCIL has informed NeSL about revised details of articles applicable in the UT of Dadra and Nagar Haveli and Daman and Diu. The revised details of articles are given in **Annexure 1** below. The usage of the articles with revised description, on NeSL DDE Platform, is being permitted solely on the basis of communication received from SHCIL and in line with the corresponding changes made by SHCIL on its website. **Kindly note article related changes have been deployed in production w.e.f 29-Jan-2026 at 8.30 pm.**

The users shall be responsible for selecting the right article code/stamp duty amount apt for the contract type or validity of the DDE agreement executed on the DDE platform. NeSL is not responsible for any deficiency in payment of stamp duty, if any, that might arise.
