In exercise of the powers conferred as Appointing Authority, as per Rule 2 (c) and under Rule 12 read with Rule 13 of the Odisha Stamp (payment of Duty by means of e-tamping) Rules, 2015 as amended till date and in pursuance of the clause 1.1 (ii) of the Agreement executed on 7th Day of June-2016 with SHCIL for implementation of e-stamp process the National e-Governance Services Limited (NeSL) is hereby approved to be appointed as Authorized Collection Centre to act as intermediary between the CRA & the Government of Odisha, for collection of stamp duty and issue of dematerialized digital form of e-stamp from the NeSL web portal integrated with SHCIL for the digital paperless execution of the following non-registrable instruments mentioned below. The stamp duty chargeable shall be as per the appropriate articles of Schedule I-A, of Indian Stamp Act, 1899 as applicable to the State of Odisha and in the absence of any proper article under Sch-IA, as per Sch-I of Indian Stamp Act, 1899.
