NOTIFICATION

In exercise of the powers conferred by sections 10, 74 & 75 of the Indian Stamp Act, 1899 (Act No.2 of 1899), the Government of Tripura hereby makes the following rules to amend "The Tripura Stamp (Payment of Duty by means of e Stamping) Rules, 2018; namely:-

Short title and commencement:

1. (1)-These Rules may be called the Tripura Stamp (Payment of Duty by means of e-Stamping) (1st Amendment) Rules, 2021
- (2)-They shall come into force on the date of their publication in the Official Gazette.

Amendment of Rule 2:

2. In the Tripura Stamp (Payment of Duty by means of e Stamping) Rules, 2018 herein after referred to as the said rules, for clause (k) of sub rule (1) of Rule 2, the following clause shall be substituted, namely,

"(k) E-stamp means an electronically generated impression on papers to denote the payment of stamp duty and includes digital E-Stamp in a dematerialized format to be used in contract or agreement executed by bank and financial institutions".

Amendment of Rule 22:

- (3) In the said rules, after sub rule (2) of rule 22 the following sub rule shall be inserted, namely:-

"(3) Where digital e-stamp is to be issued, it shall be issued and transmitted in the name of applicant by the Central Record Keeping Agency in such format and in such manner as may be prescribed by the Appointing Authority.
