Sir,

Please refer to your letter no. 265/M.Ni.Ni/2023-24, dated 7-6-2023, by which a proposal to include the articles of Schedule 1-B of the Indian Stamp Act, 1899 as applicable in Uttarakhand, in 2(1) and 25(4) of the Uttarakhand Stamp (Payment of fees through e-stamp certificates) (Amendment) Rules 2023 issued vide notification no. 720/2023/XXVII(9)/stamp-42/2008 dated 24-4-2023, has been made to the Government.

In pursuance of the aforesaid proposal, I am directed to state that from the date of publication of the above mentioned notification in the Gazette, payment of stamp duty under rule 2 (1) (i) & 25(4) of the Uttarakhand Stamp (Payment of fees through e-stamp certificates) (Amendment) Rules, 2023, approval is granted to commence e-stamping through National e-Governance Services Limited (NSEL) in association with Stock Holding Corporation of India Limited (SHCIL) through Digital e-stamping system for articles mentioned in Schedule 1 B of Indian Stamps Rules 1899 as applicable in Uttarakhand for non-registrable instruments mentioned in the following table for the State of Uttarakhand in public interest.
